be directed by Management. When a board member thinks something should be done, first it's brought out before the board. If the board decides to act, the board should vote on a motion notifying the Managing Agent, and then let the Managing Agent see that the motion is carried out.)

 reveal confidential information made available to the board to help make a business decision.

# Feral cats spread disease

The board has received many reports of stray cats prowling the yards of members. Some of the cats have kittens.

These cats are living under decks and in the field behind the garage.

At parks, zoos and recreation areas, signs are posted: "Please don't feed the animals."

It may seem unfortunate but that admonition holds true here at Independence Square for these feral cat colonies.

Stray cats carry diseases that are dangerous to people and to other animals. Pet waste is unsanitary and annoying to members of all ages who enjoy our grounds.

A recent U.S. Geological Survey study of streams and creeks in the Kansas City region showed that bacteria from pet waste is the source of about 25 percent of the bacteria in local waterways.

When pet waste is not disposed of, water quality isn't the only thing that suffers. Adults working in their gardens, children playing outside and family pets are at risk for infection from some of the bacteria and parasites in pet waste.

Another hazard is created when food is left out for the feral cats: it attracts rodents and roaches.

We are asking you to please not feed the stray cats.



Once elected, all board members are required to sign the Board Member Code of Ethics.

#### **Board Member Code of Ethics**

As a member of the board of directors, I will

- listen carefully to my teammates.
- respect the opinion of other board members.
- respect and support the majority decisions of the board.
- recognize that all authority is vested in the full board only when it meets in legal session.
- keep well-informed of developments relevant to issues that may come before the board.
- participate actively in board meetings and actions.
- bring to the attention of the board any issues that I
  believe will have an adverse effect on the cooperative or
  those we serve.
- attempt to interpret the needs of those we serve to the cooperative, and interpret the actions of the cooperative to those we serve.
- refer complaints to the proper level on the chain of command.
- recognize that my job is to ensure that the cooperative is well-managed, not to manage the cooperative.
- represent all members and not a particular court or interest group.
- consider myself a "trustee" of the cooperative and do my best to ensure that it is well maintained, financially secure, growing and always operating in the best interests of its members.
- always work to learn how to do my job better.
- declare conflicts of interest between my personal life and my position on the board, and abstain from voting when appropriate.

As a member of the board, I will not

- criticize other board members for their opinions, in or out of the board room.
- use the cooperative for my personal advantage or that of my friends or relatives.
- discuss the confidential proceedings of the board outside the board room.
- promise how I will vote on any issue before a meeting.
- interfere with the duties of the administrator or undermine his or her authority with staff members.
- act as a director outside of board meetings unless so authorized by the board. (Outside the board meetings, the board member is just like any other member. A board member's status is restricted to times when the board meets as a group to hear reports, discuss problems, make reports and make decisions.)
- direct the cooperative staff. (Cooperative staff are to
