# Residents can recycle variety of items in bin

Recycling is now as convenient as the bin by the maintenance building.

Residents can deposit all recyclable items in the bin without separating them first.

Here's what you can deposit:

Paperboard such as empty cereal boxes Brown paper bags Phone books, catalogues and magazines Newspapers Paper cardboard, dairy and juice containers Bulk mail Glass bottles and jars

Remove and discard lids.

Aluminum cans

Plastic bottles and containers #1 - #7

No plastic bags.

Tin or steel cans

Cardboard boxes

Office and school paper

Here's what cannot be deposited in the recycling bin:

No batteries

No bubble wrap

No chemicals

No diapers

No plastic foam containers, cups and packing peanuts

No food-soiled paper or plastic containers

No hardbound books

No household hazardous waste

No kitchen oils

No paint

No plastic bags

No plastic utensils

No tires

No yard waste

# **Charges apply** for bulky trash disposal

The waste disposal company that collects trash from the dumpsters also will haul away large items.

There is a charge, however, for large items the trash collector picks up and hauls away. Costs range from \$3 to \$20 and include chairs, couches, television sets, microwaves, vacuums, tables, dressers, mattresses, bed frames, gas grill and other oversized items.

Please call the office to find out what the fee is.

## Available at the office free to members

#### Yard waste bags

Trash bags only for leaf clean-ups are provided to members.

#### Pre-bagged ice melt

Stay safe this winter -- scatter some ice melt on sidewalks, stoops and steps.

#### **Furnace filters**

Change filters regularly to keep your furnace heating efficiently.

#### Smoke detector batteries

When you change your clocks, change your batteries, too.

#### **Bed bug monitors**

These early-detection devices are designed to be placed under mattresses and other bed bug spots. The bugs are trapped in adhesive and easily detected through a clear window.

If you suspect you have bed bugs, call the office. Please do not come in to make a report.

We can deliver the bed bug monitors to you.

#### **Light bulbs**

Light bulbs are provided for appliances and front and back porch light fixtures in an effort to encourage members to leave these lights on at night for security purposes.

# How Payments, Late Fees Are Applied

When you make a payment to Independence Square, the money is applied to your account in this order: attorney fees are paid first, filing fees next, then late charges, work orders and finally, carrying charges.

The money is applied to the work order unless you are on a payment agreement plan.

A late charge of \$50 will be assessed to all unpaid accounts after 5 p.m. on the 10th day of every month. If the 10th falls on a weekend, payments must be in the office by 5 p.m. on the first workday after the weekend.

All payments after the 10th of the month must be paid by a money order or cashier's check.

# Please register pets, vehicles

Pet and vehicle permits are now due.

If you have not registered these with the office, please do so. The deadline is February 28.

The only animals needing a pet permit and the one-time fee are dogs and cats.

Pet registration requires a copy of the certificate verifying vaccinations are current. The certificate also must indicate breed and weight.

A photo of your pet must be provided to the office. Proof of licensing with the City of Independence must be shown as well.

All vehicles owned by or in the possession of members or their family must be registered at the site manager's office. When a vehicle is replaced, it is the member's responsibility to file a new registration permit with the office within 10 days.

A limit of one vehicle per licensed driver per townhouse, with a limit of three vehicles per townhouse, will be permitted.

All vehicles must have a valid state license plate. Vehicles not properly licensed will be subject to towing at the owner's expense. Vehicles are subject to towing if parked anywhere other than in the member's numbered spot or a guest spot.

If a vehicle is parked in a fire zone, it will be towed immediately.

If a vehicle is blocking a member's numbered spot or is parked in a member's numbered spot, an attempt will be made to locate and contact the vehicle owner. If the owner cannot be located, the vehicle is subject to towing immediately.

Failure to comply with registration and rules may place your Occupancy Agreement in jeopardy.

# **Loose trash attracts** pests, identity thieves

Please remember to put your trash in bags and to place it inside, not next to, the dumpster.

Members who empty their trash cans directly into the bin are creating a mess for the maintenance staff. When the dumpster is picked up, loose trash is blown all over the grounds. Litter and garbage strewn throughout the complex are unsightly and unsanitary.

Those steak bones, candy wrappers, soft drink cans, coffee grounds and banana peels will end up scattered all over the grounds by critters scavenging for food.

## Tips to prevent car break-ins

- 1. Always lock your vehicle doors. Close windows and sunroofs.
- Keep personal items out of view such as keys, phone adapters, chargers and compact discs.
- 3. Keep or hide shopping bags. Don't leave them in your vehicle. Place shopping bags in your trunk and then bring them inside as soon as you get home.
- 4. If your vehicle has an alarm, make sure you set it when locking your car.
- 5. If your vehicle stereo is removable, take it inside with you when you are home.

Please keep your eyes open for any strangers in the area. Who is that? I haven't seen that person before. Why are they walking around the vehicle? Observing and reporting such activities any time of the day or night can help keep your community safe.
