Bill called the meeting to order at 5:45 p.m.

Minutes of the July board meeting were approved. The next meeting is the annual meeting on September 19.

Dudley reviewed the attorney status report.

Open Session

Six members signed in. Bill welcomed them and called the session to order at 6 p.m.

Mike gave the maintenance superintendent's report. Gutter cleaning has been completed. The retaining wall on Buildings 2 and 8 has been replaced.

A tree behind 1373 has been removed.

The fence behind Buildings 2 and 13 will be replaced next month.

Parking lots have been sealed and striping completed. Replaced since July 17 were one refrigerator, one bath faucet, one kitchen floor, three bath floors, one tub, one water heater and two bath sinks.

There have been three move-ins and three move-outs. Of 109 work orders called in, 102 have been completed. A new maintenance technician will start on August 29.

Alexis presented the office report.

One membership is for sale and two applications are pending. Four move-ins are scheduled. Three intents to vacate have been filed. No units are currently available.

The annual meeting is on Wednesday, September 19, and two board positions are open.

The office will be closed for Labor Day, September 3.

Melva presented the managing agent's report.

One application has been approved and one denied. Linville Management processed \$107,327.29 in accounts payable for the month of July. Financial reports were mailed

Remember to mow fenced back yards

Members are responsible for mowing fenced backyards.

Grass must be no higher than eight inches and the yard must be kept free of clutter.

If you receive notice from Maintenance to mow your yard, you will have 48 hours to do so. If not mowed during this time, Maintenance will mow and a fee will be charged.

If you leave for vacation, remember to make arrangements to have your yard mowed while you are gone.

If Maintenance has to mow, your account will be billed for the service. If a members gets three notices for mowing violations during mowing season, the fence will be removed.

Charges apply for bulky trash disposal

The waste disposal company that collects trash from the dumpsters also will haul away large items.

There is a charge, however, for large items the trash collector picks up and hauls away. Costs range from \$3 to \$20 and include chairs, couches, television sets, microwaves, vacuums, tables, dressers, mattresses, bed frames, gas grill and other oversized items.

Standing water breeds mosquitoes

Members with wading pools for children are reminded to empty their pools daily.

Pet owners who leave bowls of drinking water outdoors for their pets are also asked to provide fresh water daily.

Standing water becomes a breeding ground for mosquitoes and the diseases they can spread.





- Glass bottles and jars
 Remove and discard lids.
- Aluminum cans
- Plastic bottles and containers #1 #7
 No plastic bags.

- Tin or steel cans
- Cardboard boxes
- Office and school paper

Here's what cannot be deposited in the recycling bin:

- No batteries
- No bubble wrap
- No chemicals
- No diapers
- No plastic foam containers, cups and packing peanuts
- No food-soiled paper or plastic containers
- No hardbound books

- No kitchen oils
- No paint
- No plastic bags
- No plastic utensils
